## Co-parenting for Successful Kids

“Co-parenting for Successful Kids” is a research-based education class designed to help separating and divorcing parents cope with divorce and custody.

The goal of this class is to develop respectful, responsive, and responsible co-parents. Parents learn how to answer their children’s questions about the separation/divorce, and how to keep their children safe and out of the parents’ conflict. “Co-parenting for Successful Kids” strengthens communication skills that can improve interactions between children and parents.

This class is offered:

- online and available anytime
- in English or Spanish
- in person by appointment
- at several locations in Nebraska

In person classes may be scheduled by appointment at several locations across Nebraska. Instruction will include educational presentations, videos and booklets. A Spanish interpreter is available upon request.

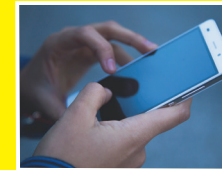
